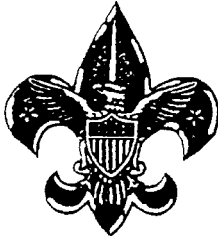

Accused Molester Convicted

A former boy scout leader accused of molesting a 13-year-old girl was found guilty by a jury Friday evening.

Albert W. Otte, 33, of Seven Hill Road, Chicora R.D. 3, was found guilty of involuntary deviate sexual intercourse, corruption of minors and indecent exposure.

The eight-woman, four-man jury, which deliberated for more than six hours, found him not guilty of statutory rape.

Otte remains free on bond pending an appeal of the verdict within 10 days.

Otte was accused of touching and later forcing sex on a Butler girl who was 13 at the time of the incidents. The assaults occurred in 1989 and 1990 in Butler where he lived at that time.

During testimony Thursday, the girl said Otte began the encounters by explaining what he thought she ought to know about men and women's sexual organs and how to check for breast cancer. As time went on, he touched her body parts while he explained them and later the touching progressed into sex, the girl testified.

The teen-ager said she did not report the incident to anyone because she was afraid of Otte since he had hit and kicked her previously.

The Oakland Township man suffers from seizures and had an often violent personality that is currently controlled by medication, according to his own testimony.

Otte had a job driving a van for United Cerebral Palsy in Butler County until his seizures became too dangerous, he said. He no longer works, and receives social security disability compensation.

Assistant District Attorney William Shaffer brought up part of Otte's criminal record during court Thursday.

In 1984, Otte was charged with taking \$75 from a pinball machine owned by the Cranberry Township Volunteer Fire Co. and was sentenced to pay back the money. Shaffer said the crime was mentioned because it is the type of act that casts doubt on Otte's ability to testi-

fy truthfully.

Shaffer said after the trial that he could not mention arson and criminal conspiracy charges for which Otte spent two months in prison in 1984, since those acts do not show the kind of deceitfulness that a theft does.

In his opening address to the jury, Otte's attorney, Alexander Lindsay, said he questioned the truth of the girl's testimony because the details she gave of when and where the assaults took place had changed too much between the time of the preliminary hearing and the trial.

Lindsay said her recollection may be better now because she had talked with her mother, who did not get along with Otte.

Shaffer said the girl's story has become more clear since she began thinking harder about the incidents for the trial.

The same girl was molested by another man when she was nine. That 43 year-old man, Joseph Corzin of Butler R.D. 2, pleaded guilty to indecent assault in 1987 after being accused of placing her on his lap and touching her breasts and groin area in the basement of the YWCA, according to court records.

Butler Man Charged With Sexual Assault Of 12-Year-Old Girl

A Butler man was placed in Butler County Prison Thursday by Butler City Police after he was charged with assaulting a 12-year-old girl over a three-year period, according to documents at District Justice Thomas Doerr's office.

Albert William Otte, 33, of 326 Franklin St., was charged with rape, statutory rape, involuntary deviate sexual intercourse, corruption of minors and indecent assault.

He was released from prison the same day after posting a \$2,000 cash bond.

REVIEW PROCEDURES

The following information is provided should you desire a review by the Northeast Region, BSA, of the decision to deny your registration.

1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to the regional director, Northeast Region, BSA. In your request you may include your version of what occurred in support of your claim that your registration should not have been denied.
2. Upon the receipt of your written request, a committee will be appointed to review the situation.
3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
5. You will receive a letter setting forth the decision of the committee.
6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.
