This is to give you information of the police report on one
Mr. David Brendel of Reading Penna.

On Wed. May 27, 1967 I received a call from a Mrs. [redacted] of [redacted]
[redacted] West Lawn Penna. She reported to me that Mr. Brendel was after her son.
He is [redacted] D.O.B. 1-27-53 and is boy scout troop 414 of West Wyomissing Fire Co.
West Wyomissing, West Lawn Penna.

Mr. Brendel had taken her son for a ride in his truck after the boy scout
fair on May 21, 1967. There was a [redacted] of [redacted] West Lawn Penna. with
them in the truck. They drove around in Reading and stopped for something to eat.
After this Mr. Brendel dropped [redacted] off at his home. He then took [redacted] for a ride.
They stopped along the "road to no where" as we call it. The road is VanReed Road in Spring
Twp. West Lawn Penna. When they stopped Mr. Brendel tried to play with [redacted]. [redacted] told
me that he didn't let him. Mr. Brendel then brought [redacted] home.

[redacted] also told me that Mr. Brendel tried to play with him up at
summer camp last year. He used to come into the tent every morning and try to play with [redacted].
He also tried to play with a [redacted] of West Wyomissing Troop 414. at camp. The [redacted]
boy is no longer in the boy scout troop.

I called Mr. Glen Hostetter about Mr. Brendel and what had happen.
Mr. Hostetter and myself had a meeting with the officer,s of the West Wyomissing Fire Co.
The scout master of the troop was also in on the meeting. Mr. Brendel will not be aloud
to come on the fire company property at anytime, also may not help with the scout troop
at any time or any where. This is what the fire company officer,s told us.

Mr. Brendel was a driver for the Junior Fire Co. of Reading Penna.
and was driving the ambulance. I checked with the fire chief of the city of Reading on
Mr. Brendel. He told me that he was checking on him for the same thing. Mr. Brendel is
no longer working for the Reading Fire Dept. At this time know one know,s were he went to.

He is 22 yrs of age about 5'10" 150 to 165 lbs. He drives a 1967
Ford Pick-up. Color dark blue.
