After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are attached.

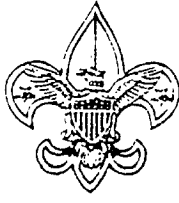

Dear Dennis:

I would like to take this opportunity to confirm in writing the meeting that Tom Lehmier, John Pyfer and I had with you on September 24, 1986. The purpose of the meeting was to discuss with you concerns that had had been brought to our attention regarding your conduct with boys on various occasions. These concerns lead to our requesting that you submit Child Abuse Clearance, form CY 113, as set forth in PA Act 33 of 1985.

I pointed out to you that child abuse has become a cancer in our society - that it can happen almost anywhere - that it can happen in Scouting - that it cannot be ignored - and that the three of us have the responsibility to assure that it doesn't happen in the Lancaster-Lebanon Council.

We have a responsibility to assure that our leaders meet the high standards established by the Scout Oath and Law. Quality Leaders and Quality Program are Keys to the success of Scouting.

In our opinion, you have made several errors in judgement over the years which have culminated in our recent decision to suspend your registration pending receipt of certain child abuse clearance reports. Bases upon these reports, which you have submitted, we have decided to reinstate your registration.

Thank you for your letter of August 19 concerning the above-named individual. It sounds as if this individual is very immature in his leadership of youth. He has made some very poor judgment decisions in his actions.

We certainly feel that you have indicated enough evidence of poor leadership to warrant action and refusal of registration. We may not be able to maintain a file nationally, but, certainly, you should be able to refuse registration locally based on the material transmitted.

We would suggest that you try to get more material, if possible, and any statements from individuals related to Mr. Geiter's actions. His actions would upset many youth and parents, but might not hold up in a court of law if anyone pressed action at this time.

Let us know if we may be of help to you from this office. We would like to have a Confidential Record Sheet completed which we are enclosing with this letter.

Following is a history of Mr. Dennis C. Geiter in our Council, leading up to his suspension on June 27, 1986.

In the fall of 1984, the Committee of Troop 127 requested my presence at one of their meetings; the main subject was - the question of leadership quality of their Scoutmaster, Dennis C. Geiter. Many of the parents and leaders were concerned about the actions of Mr. Geiter. Evidently, he liked to do something he called "Rub-a-dub-ie." He would rub noses with the boys and then kiss them on the lips. It was agreed that I should have a talk with Mr. Geiter.

At the next roundtable, I took Mr. Geiter aside and talked to him about body language and the possibility of sending the wrong signals to observers, i.e. kissing boys on the lips could be misinterpreted by parents and other observers. Since Mr. Geiter is a likeable person, it appeared that he needed some guidelines on acceptable behavior. (Mr. Geiter is a bachelor.)

The next summer, the Committee of Troop 127 had suspicions about Mr. Geiter and asked that he not stay with the boys at Scout Camp. Following was an investigation by the PA Child Hot Line for Child Abuse. Mr. Geiter was asked to resign as indicated in a letter from Mr. Bill Neely, Chairman of Troop 127 Committee (letter enclosed, received Oct. 15, 1985). The results of the investigation was "unfounded" because the incident did not occur or was not of a serious nature (letter enclosed, dated April 4, 1986 from the Lancaster County Children and Youth Agency).

In the meantime, Mr. Geiter kept his registration with the Committee of Pack 127, and registered with Troop 25 of the 6th Ward Citizens Association, and Troop 16 of Saint Joseph's Holy Name Society.

Since the standard of leadership is a responsibility of the unit committee and chartered partner, the council office continued to observe and kept itself informed as to the leadership status of Mr. Geiter.

However, this changed in June , 1986 when our Council Executive, Mr. Thomas F. Lehmier, heard the following report from Mr. Willoughby Litzenberger of [REDACTED], Manheim, PA 17545 [REDACTED]

One year ago, Mr. Litzenberger was at Mr. Geiter's cabin below Holtwood, PA. Evidently, it was crowded so one of the boys had to sleep in Mr. Geiter's bed. The next morning, Mr. Litzenberger saw the boy get out of bed with an erection. Mr. Litzenberger explained to Mr. Geiter that this was unacceptable behavior. Mr. Litzenberger is a Unit Commissioner and a Veteran Scouter.

Mr. Morris Lapi of [REDACTED] Denver, PA 17517 [REDACTED] J. Edward Mack Scout Camp Director recalled the following event: two years ago, Mr. Lapi was going through Mr. Geiter's campsite. He noticed that there was an extra bed in the leader's tent. Mr. Geiter's tent, and that Mr. Geiter was in there with his arms around a number of boys. All of them were in their under shorts. Mr. Lapi informed Mr. Geiter that extra beds were not permitted in any tent and that this kind of behavior was not acceptable at camp and he didn't want to see it again.

Another incident was reported by Mr. George D. Robb, of [REDACTED] Lancaster, PA 17603 [REDACTED]. At a winter campout in 1986, he saw Mr. Geiter kissing boys on the lips.

It seems that Mr. Geiter has not heeded the repeated warnings of many Scouters.


Enclosed is a copy of the letter our Council President, Wayne W. Ackerman, mailed to Mr. Geiter, dated June 27, 1986.

It suspends Mr. Geiter from registration with the B.S.A., pending receipt of a PA State Child Abuse Clearance.

In the beginning of August, 1986, our office received the results of the Child Abuse Clearance and a request for Criminal History Record (both enclosed). Mr. Geiter is not listed on the files as a perpetrator of child abuse and he has no record of criminal history.

In the light of the above history, please advise us of your recommendation on the registration of Mr. Dennis C. Geiter.

Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be granted or reinstated.
