Dear Paul:

In regards to the situation concerning Mr. Dreisbach, I had a number of telephone calls from three former Scouts who claim to be victims of sexual abuse by Mr. Dreisbach in the early 1970's. I know the identity of two of the callers, however all three wish to remain unidentified for fear of reprisals in the community.

I have been unsuccessful in obtaining written statements from any one involved. Mr. Dreisbach has not requested a review of our decision to suspend his registration. He has not, to my knowledge, had any contact with the Boy Scouts Of America since our letter to him on June 23, 1989.

The only corroboration I have is that my Council President, Bernard C. Banks, Jr., listened in on one of the phone calls alleging the abuse. I contacted Mr. Jerry Pitkas of the Wyoming County Children and Youth Services, to whom we reported the incident. He told me that because he had no first hand accusation, he could not launch a full investigation. He did talk to two boys who recently quit the Troop and neither boy made any accusations. Mr. Pitkas passed the information, including a list of former Troop members, on to the District Attorney for Wyoming County.

Please advise as to any further action on my part.

Dear Mr. Dreisbach,

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

Statement 7/12/89

On June 23, 1989 and July 10, 1989 I received phone calls from two former members of Troop 336 alleging that Mr. Edward (Ted) Dreisbach sexually abused [redacted] and other members of the Troop on numerous occasions from 1972 to 1977. Acts included fondling and oral sex.

[redacted] stated knowledge of others being abused in later years. [redacted] was registered as Webelos Leader [redacted] the years indicated.

[redacted] less outlined emotional manipulation and threats to coerce boys into cooperation. The acts are alleged to have occurred at Dreisbach's home and on Scouting Trips

[redacted] not want to be identified due to fears of reprisal and damage to their reputations or careers

[redacted] were asked to call the Wyoming County Children + Youth services directly. I reported [redacted] myself and then instituted action to suspend registration. Notice was served on

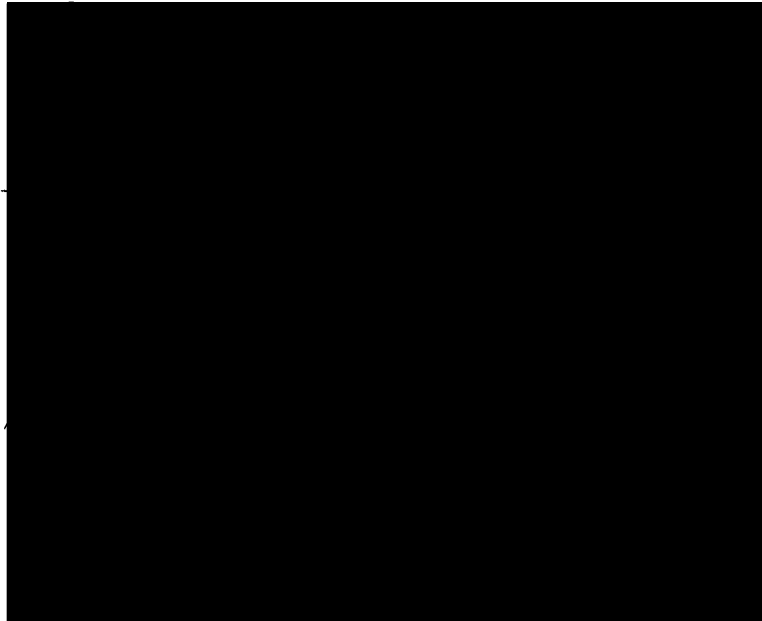

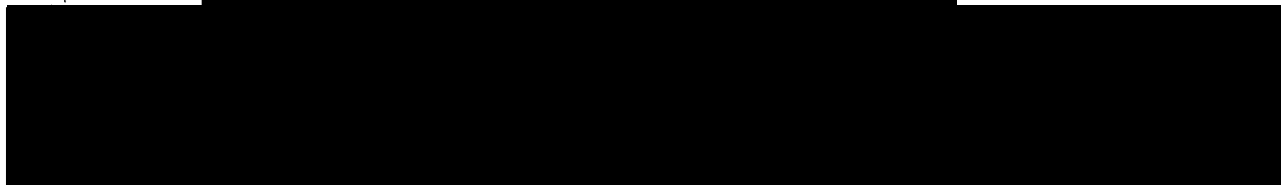

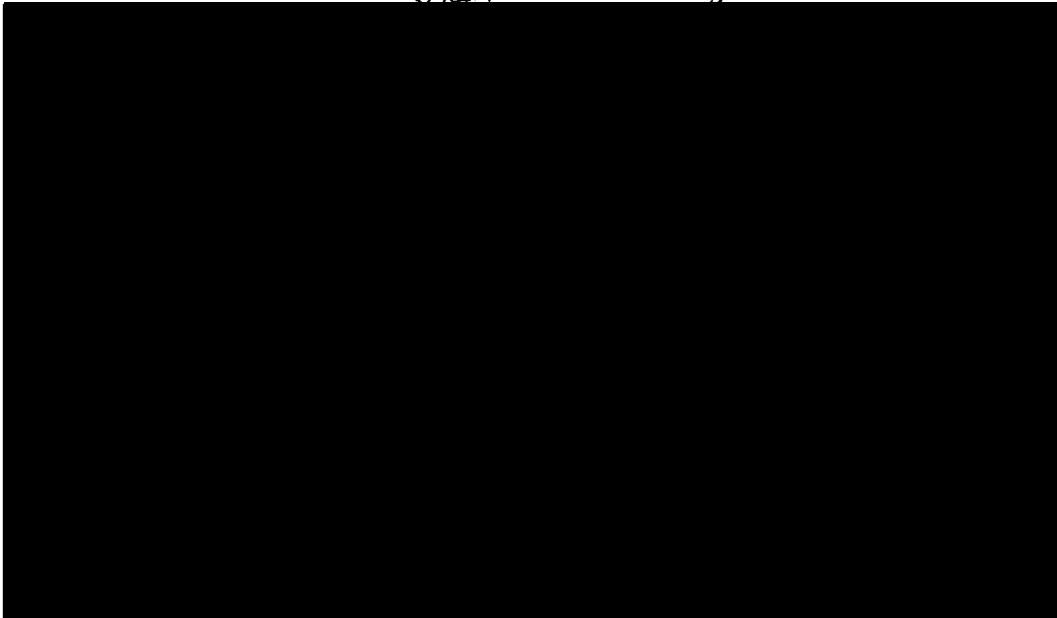
