I really appreciate anything you can do, so that we can close this file.

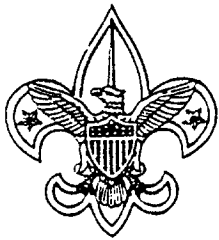

Dear Paul,

This is a follow-up letter in reference to Edwin A. Drzewinski of Clintonville, PA.

I had a long conversation with Reverend Runge of Lamartine, PA who is a Lutheran Pastor. He stated that much of the comments that he made to me about Mr. Drzewinski were hearsay and therefore would not put anything in writing. He told me that at one time Mr. Drzewinski was a Scoutmaster of a Troop in Fox Chapel, PA and again in Slippery Rock, PA in the 1970's and 80's. In both cases he got into sexual activity and caused parents to pull youth out of the troops thereby causing their dropping of the unit. The parents did not pursue any legal action. As a result, this man has had no legal action taken against him.

The Pastor stated to me that Mr. Drzewinski was a storyteller and you never know what to believe of him. Currently he is temporarily living in the Philadelphia area doing something supposedly for the IRS. I have been told he is about 45 years old.

Wish I could have more details for you, PAul, but that's it. I'm firmly convinced, after the conversation with Pastor Runge (██████████ if you feel you need to talk with him) that Mr. Drzewinski needs to be kept out of the Scouting Program before he does any more damage.



In March, we received a telephone call from Sandy Allison, in Council No. 532. He indicated that this individual lived at [REDACTED]. He also indicated that his date of birth was January 14, 1939.

He apparently was registered at one time in the Moraine Trails Council, in Troop S0311. The unit he was with there apparently folded soon after he joined the troop.

It was also indicated that he was in your council and was dropped in 1987. Unfortunately, he did not give us a unit number. I don't know if you can get more information if you contact Sandy.

We were given the information that Mr. Drzewinski should not be around young people. I am really groping for more information to determine if this individual should be placed on our confidential file. We would of course need more information if this proved necessary.


