Dear Paul:

On March 17, 1989, we found it necessary to suspend Mr. Herman Suggs as a member of the Boy Scouts of America because of allegations regarding Mr. Suggs which we were required to report to the Commonwealth of Pennsylvania and, specifically, to Berks County Children and Youth Agency.

Senior District Executive Ray Braun brought to my attention an allegation of sexual abuse to [REDACTED] former Scout in Mr. Suggs's Boy Scout Troop 299, sponsored by Thankful Baptist Church, Philadelphia, Pa.

Attached you will find a copy of the letter signed by Council Vice President, Frederick A. Welsh, suspending Mr. Suggs's membership, copy of official notification to Berks County Children and Youth Agency, including attachments, and a copy of a letter from Mr. Suggs directed to John Hunt, our Director of Field Service, which we received on March 22, 1989, wherein Mr. Suggs refused our refund of his registration fee.

It is my understanding that the Berks County agency has turned over the investigation to the Philadelphia Department of Human Services.

We will advise you if there is any change in Mr. Suggs's suspension.

Dear Mr. Suggs:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are, therefore, compelled to request that you sever any relations you may have with the Boy Scouts of America. A refund of your registration fee is enclosed.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of membership the BSA seeks to provide for American youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.

APPLICANT PROCEDURE FOR REQUESTING REVIEW
OF DECISION DENYING REGISTRATION

1. If registration is refused, the applicant may request a review of this decision. This request must be in the form of a written request from the individual which includes his or her version of the facts supporting the claim that registration should not have been denied.
2. Upon receipt of the written request for review, the President of the local Council shall appoint a committee to review the situation.
3. The appointed committee should review the facts as presented, and, in addition, may interview any persons whose testimony might assist the committee in discovering the truth and arriving at a correct decision.
4. A confidential report will be given to the applicant setting forth the decision of the committee.
5. The applicant may -- if he or she does not agree with the decision -- request a review from the Regional Director by submitting a written request for such a review within 30 days of the receipt of the local Council decision.
6. If the Regional review does not satisfy the applicant, he or she may ask for further review by the National Council by submitting a written request for such a review within 30 days of the receipt of the Regional decision. The decision by the National Council is final.

M. today, March 17, 1989, it was brought to my attention by Mr. Raymond Braun that he learned of an allegation of sexual abuse to [REDACTED], at the time, was a member of Boy Scout Troop 299, sponsored by the Thankful Baptist Church in Philadelphia, Pa. The allegation of abuse was brought to Mr. Braun's attention by [REDACTED]. The person accused is Mr. Herman Suggs.

Attached you will find Mr. Braun's report to me outlining the allegations as we know them. I have reported this, as of 3:30 P. M. today, Friday, March 17, to Mr. Chuck Whitesell in Harrisburg, Pa.

Earlier this week I received a phone call from Gayle McElven - Den Leader for Pack 299. She informed me that she met a young man who left Troop 299 because he saw Mr. Suggs (the Scoutmaster) try to molest another Scout on a trip. I asked her for the boy's name and details. She told me that she would find them and get back to me.

On Thursday, March 16, 1989, she called and gave me the information that she had. She told me that she was riding with [REDACTED] (a member of her church Gospel Choir) past Thankful Baptist Church. She pointed out to him that this is where her Cub Pack meets. He then told her that he used to go to Thankful for Boy Scouts with Mr. Suggs. Ms. McElven asked why he stopped going to Scouts. His answer was that about four (4) years ago on a trip to New York city. Mr. Suggs tried to molest one of the Scouts. Gayle asked him if he was for real. His answer was yes, that is why he stopped going. Gayle asked if he told anyone. He said that he told Rev. Trapp, the Pastor, but nothing happened.

4:45 p.m.

I called and asked for [REDACTED]. A lady who answered, identified herself as his grandmother ([REDACTED]), said he was not home. I told her that I was calling about a problem that [REDACTED] had in Scouting. She told me that she was aware of the problem. She said that [REDACTED] and another Scout (she did not know his name) came home crying from the camping trip. She told me that [REDACTED] said he was approached by Mr. Suggs. She reported this to Rev. Trapp (then the Pastor, since has passed away). She received no response from Rev. Trapp, so she stopped [REDACTED] from going to Scouts. She told me that he is now 15 years old and that he was about 11 years old at the time of the trip. I told her that I would call back later to talk to [REDACTED].

I talked to [REDACTED] and told him how I was and that I was calling about a problem he has in Scouting. I asked him if he would tell me about the problem and he agreed. He told me that this was his first trip with Troop 299 and that he was about 11 years old. He did not remember the date. He joined Scouting about one or two months before.

Their camping trip was to a Camp Trovolter (he thinks owned by Thankful Baptist). After dinner and later that evening the Scouts were playing around with flashlights. Mr. Suggs got mad and told them to go to bed. [REDACTED] noticed that Mr. Suggs moved his ([REDACTED]) sleeping bag away from his friends and next to his (Mr. Sugg's). After [REDACTED] went to bed he felt Mr. Sugg's hand feeling him. [REDACTED] said he was afraid to make any noise. He finally got up and moved his sleeping bag away from Mr. Suggs. The next morning, Mr. Suggs called a meeting of all the Scouts. He talked to the boys about homosexual activities and told them that nothing happened the night before. He continued to say that if anyone says anything he would deny it. He went on to tell me that another boy, [REDACTED], was also involved at another time, but would not tell anyone about it. [REDACTED] told [REDACTED] that he stayed at Mr. Suggs house, and that Mr. Suggs touched him at that time. [REDACTED] went on to tell me that Mr. Herman turned the other Scouts against him. He came home adn told his grandmother and they told Rev. Trapp with no outcome. He went on to tell me that he still had his Scout uniform and that he would still like to be a Scout.
