This morning I spoke with the Philadelphia Police Public Affairs Office to confirm a rumor that one of our Scoutmasters had been arrested over the July 4, 1989 holiday.

The department confirmed that on July 5 an Officer DeBlosie arrested John G. Saunders for simple assault, indecent assault and corrupting the morals of a minor. He was held in the sex crime lockup and is being turned over for arraignment.

A violation of any "employment conditions" as contained in my "Agreement for Day Camp Staff Employment" will be sufficient reason to be discharged for "willful misconduct" under Section 302A of the PA Unemployment Compensation Law and therefore relieves the above Council from any and all future unemployment claims or charges.
3. That I accepted employment knowing it is a seasonal position only and wish to have this letter, also, considered as a letter of resignation effective the last day of contracted employment. I fully understand this resignation makes me ineligible to file an unemployment claim either in part or full against the Valley Forge Council, BSA.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not meet the high standards of membership which the BSA seeks to provide for American youth.

If you wish to have this decision reviewed by a council review committee, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be reinstated. The procedures for a review of this decision are enclosed.
