The following is the information you requested on the above named parolee.

This man appeared in the 1961 September Sessions of Criminal Court of Dauphin County charged with Sodomy and Corrupting the morals of a Minor. He was found guilty on both charges and was sentenced to not more than 15 months and not less than 5 months in the Dauphin County Prison, but immediately paroled on the condition that he receive psychiatric treatment. These sentences run concurrently with \$5.00 fine and costs on each charge.
